

## ArtStarts in Schools – Criminal Record Check FAQ for Artists on Tour

For the purpose of this document, please note that “CRRP” refers to the BC Ministry of Justice’s Criminal Records Review Program.

### When do I have to complete my criminal record check by?

- To be included in the Artists on Tour Directory for the 2018-19 school year (published in February 2018), individual artists must complete or share a criminal record check through the CRRP by February 1, 2018.

### Who has to complete this criminal record check?

- All artists, including all members of a group, must complete the criminal record check process. This includes artists/performers, including alternate members, as well as those in support roles (e.g. Director, Stage Manager, etc.) who will be entering schools to work with or perform for children. All individuals aged 12 and over must complete the criminal record check process.

### How do younger members of our group complete the criminal record check through the CRRP?

- Artists aged 12-18 cannot complete the CRRP online. They will have to download and complete the manual process by downloading two forms from the CRRP website.

- Artists aged 11 and under do not need to complete the criminal record check process.

### The members in our group change for different performances. Does everyone need to complete this criminal record check process?

- Yes, all members of your group who will be entering schools to perform for or work with children must complete this criminal record check process. This includes alternate members of your group who may not tour with you for all performances.

### I am listed in both the Artists on Tour Directory and the Artists in the Classroom Directory. Do I need to complete this criminal record check process twice?

- You will only need to complete one criminal record check for ArtStarts.

### What if someone joins our group after February 1, 2018?

- If someone joins your group after February 1, 2018, you must **inform** ArtStarts. The new member(s) must also complete the criminal record check process. ## ArtStarts in Schools – Criminal Record Check FAQ for Artists on Tour

For the purpose of this document, please note that “CRRP” refers to the BC Ministry of Justice’s Criminal Records Review Program.

### How much does it cost? Who is responsible for paying this fee?

- The cost to complete a criminal record check through the CRRP is \$28, to be paid by the artist during the online application process.
- If you are a member of a group, each individual must complete a criminal record check through the CRRP.

### I’ve completed a criminal record check in the past; do I still have to take part in this process?

- The only criminal record check process that ArtStarts can accept is through the BC Ministry of Justice’s Criminal Records Review Program (CRRP).
- If you have completed a criminal record check through the CRRP within the past 5 years, you do not need to complete a new one—you will simply need to share your results with ArtStarts via the CRRP website.
- If you have completed a criminal record check through the CRRP more than 5 years ago, it has expired and you will need to complete a new one.

### How often will I need to complete a criminal record check?

- Your CRRP clearance letter is valid for 5 years, and a new clearance process will need to be initiated prior to that date.

### What happens if I don’t complete this criminal record check process?

- If you do not complete the criminal record check process by the specified deadline, you will not be included in the Artists on Tour Directory.

### Are there any exceptions to this deadline?

- All exceptions to the deadline must be approved by the Program Director at ArtStarts. Please contact Rekha Pavanantharajah at 604-336-0626 ext 103 or rekha@artstarts.com.
- Groups that contract artist members annually and will not have a completed artist list in place by February 1, 2018 (e.g. theatre troupes) may be granted an exception to the deadline. Please contact Rekha Pavanantharajah at 604-336-0626 ext 103 or rekha@artstarts.com.

### How long does it take to complete the online CRRP?

- Completing the online criminal record check through the CRRP website should take approximately 20 minutes. This time may vary. (It takes approximately two weeks for ArtStarts to receive your clearance letter after you have completed the online process.)

### What happens to my results after I complete this process?

- Once you have completed the online process, the BC Ministry of Justice will share your clearance letter with an authorized staff member at ArtStarts. ArtStarts will not receive the details of your criminal record check, simply if you have or have not been successfully cleared to work with children. If you have not been cleared, you will be contacted directly by the BC Ministry of Justice. ArtStarts will keep all personal information confidential and we will not share the results of your criminal record check with individuals or organizations.

What happens if the results of my criminal record check indicate that I am not cleared to work with children?

- If the results of your criminal record check indicate that you are not cleared to work with children, you cannot be included in ArtStarts’ Artists on Tour Directory or be included in our Booking and Touring service. You will be notified directly by someone from the Criminal Records Review Program. You are responsible for letting your group representative know.
- The BC Ministry of Justice has processes in place if you wish to request a reconsideration or appeal of CRRP results. Learn more about this process at <http://www.pssg.gov.bc.ca/criminal-records-review/results/index.htm>

What happens if a member of my group is cleared, but then incurs new criminal charges or convictions after completing the criminal record check process?

- The applicant is required to repeat the criminal record check process.

I experienced an error message while on the BC Ministry of Justice’s CRRP website. What do I do?

- If you experience an error message while on the BC Ministry of Justice’s CRRP website, please call the phone number displayed on the screen to speak to a support person.

I am unable to complete the CRRP online. What do I do?

- If you are unable to complete a criminal record check through the CRRP or the associated Electronic Identity Verification (EIV) process online, you will be directed to print your form from the website. Bring this form, along with valid ID (e.g. driver’s license) to ArtStarts or another location listed below to verify your ID in person and submit your printed form.
  - If you are located in the Lower Mainland, please call ahead to make an appointment to meet with a staff member at ArtStarts in Schools, 808 Richards Street, Vancouver. (Members of the Artists on Tour Directory should contact Rekha Pavanantharajah at 604-336-0626 ext 103.)
  - If you are located elsewhere, you can visit your local Service Canada location, police station, post office or bank.
